# A. Merit Scholarship (Applicable in 1st year only)

- 1. 90% & above = 40% Tuition Fee Wavier 3. 70% 79.9% = 20% Tuition Fee Wavier
- 2. 80% 89.9% = 30 % Tuition Fee Wavier 4. 60% 69.9% = 10% Tuition Fee Wavier

### **B. UTTARAKHAND STATE DOMICILE SCHOLARSHIP**

The GRD-IMT Dehradun offers **10% Scholarship** on Tuition Fee to Uttarakhand Domicile Students, 40% of seats for these students are reserved throughout all the programmes of the GRD-IMT/GRD-PG Dehradun.

To avail the scholarship student must carry Original Domicile certificate of Uttarakhand State at the time of admission.

#### C. SCHOLARSHIPS FOR STUDENTS HAVING DOMICILE OF HILL STATES

The GRD-IMT Dehradun offers **10% Scholarship** on Tuition Fee to Hill States \*Domicile Students.

For availing the scholarship the student must carry Original Domicile certificate of respective Hill States<sup>#</sup> at the time of admission.

### D. GRD-IMT SCHOLARSHIP FOR GIRLS

The GRD-IMT Dehradun offers **5% Scholarship** for Girl students on Tuition Fee applicable for the first year for Diploma/UG/PG programmes subject to the following condition:

• The Scholarship percentage will remain same on PAN India basis.

### E. SCHOLARSHIP FOR THE WARDS OF DEFENCE PERSONNEL

The GRD-IMT Dehradun offers **5% Scholarship** on Tuition Fee to the son/daughter of defence personnel (including Para Military viz ITBP, CRPF, etc.).

## F. SCHOLARSHIP FOR ALUMNI SIBLING

The GRD-IMT Dehradun offers 5% Scholarship on Tuition Fee only to the brother/sister of Alumnus.

To apply for the scholarship the student must carry the following documents at the time of admission.

- (i) Aadhaar / any valid photo ID proof of the student bearing the name of the parent.
- (ii) Mark sheet/Certificate issued to Alumnus bearing the names of parents.

#### G. SCHOLARSHIP FOR EXISTING STUDENT SIBLING

The GRD-IMT Dehradun offers 5% Scholarship on Tuition Fee to sibling of present student/s.

To avail the scholarship, the sibling must carry the following document at the time of admission:

• Aadhaar / any valid photo ID proof of the student bearing the name of the parent.

#### OTHER CONDITIONS

- 2. Once Candidate/Student has opted for the scholarship, He/She will not be eligible for any other scholarship.
- 3. Scholarship will be offered on tuition fee only.
